GENERAL RULES & REGULATIONS

- 1. Registration shall be deemed confirmed only after we receive registration fees.
- 2. Each team shall be allotted a unique team code upon final registration.
- 3. Teams are forbidden from disclosing their identities to the judges or other participating teams or anywhere and must only use their respective unique team codes for all correspondence for the purpose of this Competition except with the administrators. Disclosure of identity shall lead to immediate disqualification.
- 4. The Dress Code shall be advocates attire (black and white formals for gentleman and white western outfits or Indian formals for ladies, no gowns and coat bands) to participate.
- 5. Bonafide students pursuing Five or Three Years LL. B Degree Course are only eligible. The students must be deputed by their respective colleges.
- 6. Participants participating in multiple events shall strictly adhere to the timings specified for each event. The organizers will not be responsible in case of clash of event timings.
- 7. Participants/ students must carry their respective college ID cards. Entry without the ID cards shall not be permitted.
- 8. Participants/ students shall not resort to or indulge in any unethical, unprofessional or immoral conduct. If found guilty, the organizers shall reserve the right to take appropriate action.
- 9. Participants shall bear their own travel and accommodation expenses.
- 10. The sole right of interpretation of rules and regulations and decision to disqualify in case of failure to follow rules and regulations on part of participating Team's will remain with the Organizers of this event.
- 11. Any grievance Will be settled by the Grievance Committee and the decision of the committee shall be final and binding.
- 12. The organizers are not responsible for the accommodation of the participants.

MOOT PROPOSITION

- 1. The Republic of Azuria is a diverse and vibrant nation in South Asia, home to a population of approximately 150 million people. Known for its rich cultural heritage and a rapidly expanding economy, Azuria comprises various ethnicities, languages, and religions that reflect its deep historical roots. The nation gained independence in 1952 after a prolonged struggle against colonial rule, and since then, it has developed into a dynamic democracy. In this political landscape, issues of civil rights and individual freedoms are crucial to Azurian society, while simultaneously deliberating upon the various instances of terrorism in Azuria, particularly emanating from its neighboring State, there was a need for a fortified law preventing the unlawful activities. Consequently, the Unlawful Activities (Prevention) Act, 1967 (UAPA) was enacted by the Parliament of Azuria.
- 2. Danyal Kadeem, born in 1980 at Vahini Nagar in the Dellori State of Azuria, grew up in a modest household that followed Solarism and emphasized education. His passion for history guided him to Sofiabad Public School, after which he pursued an undergraduate degree in History at Johari Lal College, Dellori. This academic path set in motion Danyal's future as a notable activist and public figure in Azuria.
- 3. Following his undergraduate studies, Danyal attended Salarjung University (SJU) for an M.Phil. and Ph.D. in History, where his political activism took flight. He joined the Democratic Students' Union (DSU), a leftist organization that was vocal about government policies and advocated for social justice. The DSU played a crucial role in Danyal's development as an activist leader as he organized campaigns on behalf of marginalized communities, establishing a reputation of a passionate advocate for civil rights.
- 4. Danyal gained national attention in 2016 during an incident at SJU, wherein he along with the other students were accused of raising anti-national slogans, during the protest campaigns criticizing the governmental policies. This resulted in Danyal's arrest, which sparked widespread debate over free speech and nationalism in Azuria. Many believed that the government's response was excessive, while others argued that the slogans threatened national integrity. This experience strengthened Danyal's resolve to champion the cause of civil liberties and resist government overreach.
- 5. In 2019, the Azurian government enacted the Citizenship Amendment Act (CAA), leading to mass protests nationwide due to its perceived bias against followers of Solarism. Danyal emerged as a prominent figure in the protests, rallying for inclusivity and equality. He argued that the CAA endangered Azuria's secular values, earning further admiration and criticism as he organized peaceful demonstrations in major cities across Azuria.





6. In February 2020, Azuria witnessed violent riots in Dellori during a visit by the U.S. President Arnold Kenny. Amidst the unrest, the government declared Dellori as a curfew zone to curb escalating protests. The Dellori Police alleged that Danyal, alongside other activists, orchestrated the unrest to incite communal discord. On September 13, 2020, he was arrested under the newly amended Unlawful Activities (Prevention) Act, 1967 (UAPA), which allows for stringent actions against terrorism. The government alleged that his hateful rhetoric in major cities across Azuria led to the violent riots in Dellori causing internal unrest across the country, a charge that positioned him as a threat to national security. The arrest, the first of its kind under the amended UAPA, marked a significant shift in the government's approach to dissent.

7. Based on inputs received by the Government, the Ministry of Home Affairs intercepted phone calls of the key members of the DSU, who were actively protesting Danyal's arrest. Acting on these interceptions, the Ministry directed the National Investigation Agency (NIA) to initiate an investigation into Danyal's activities. While the investigation was still ongoing, the government declared the DSU a terrorist organization under the Unlawful Activities (Prevention) Act and swiftly detained all individuals associated with the group, citing national security concerns.

- 8. The UAPA's 2019 amendments introduced Sections 35 and 36, enabling the government to designate individuals, not just organizations, as terrorists. The expanded powers were criticized for enabling the government to target dissenters without trial or judicial oversight, sparking concerns over arbitrary use against political opponents. Danyal's designation as a terrorist under these new provisions became a test case for the implications of the amended UAPA.
- 9. Both the DSU and Danyal, in a bid to challenge this designation, submitted an application to the government under Section 36 of the Unlawful Activities (Prevention) Act, seeking a review of their classification as a terrorist organization and Danyal's status as a designated terrorist. However, their application was summarily rejected by the government, once again citing national security concerns. The rejection came without providing any detailed justification or disclosure of evidence, and the government invoked confidentiality under national security.
- 10. The amendments to the UAPA, particularly Sections 35 and 36, were widely criticized for granting arbitrary powers to the government without adequate safeguards. As per the said provisions, the Central Government shall have the power to designate any organisation or an individual 'as Terrorist', 'only if it believes' that such organisation or individual is involved in terrorism. Legal experts and civil rights advocates argued that the provisions lacked transparency and procedural fairness, violating fundamental principles of due process as well as international obligations under the International Covenant on Civil and Political Rights (ICCPR) and United Nations guidelines on human rights while countering terrorism. The ability to designate individuals as terrorists based on broad and vaguely





defined criteria was seen as a dangerous tool that could be wielded against political opponents and activists. Danyal's case exemplified these concerns, prompting calls for a reevaluation of the law's scope and application.

- 11. In response to escalating unrest and legal challenges, two writ petitions were filed in the Supreme Court of Azuria contesting the constitutionality of Sections 35 and 36 of the UAPA. The Petitioners argue that this amendment gives arbitrary power to the government to target voices of dissent and opposition. The first, Writ Petition No. 550 of 2025, was submitted by Shalini Rao, a public-spirited advocate who initially raised her concerns through a letter to the Chief Justice of Azuria. The Chief Justice, recognizing the gravity of the issues raised, converted Rao's letter into a formal writ petition. Rao's petition emphasized the potential misuse of the UAPA amendments and their implications for civil liberties, calling for a thorough examination of the law's alignment with constitutional principles.
- 12. Rao's petition argued that the UAPA amendments violated due process and natural justice by permitting the arbitrary designation of individuals as terrorists without sufficient evidence or the chance for defense. She stressed the need for judicial oversight and accountability in the application of anti-terror laws, asserting that the broad powers granted to the executive posed a significant threat to democracy and the rule of law in Azuria, thereby infringing on Articles 14, 19, and 21 of the Azurian Constitution.
- 13. The second writ petition, No. 560 of 2025, was filed by the Association for Civil Liberties and Justice (ACLJ), an organization committed to safeguarding civil rights. ACLJ argued that Sections 35 and 36 of UAPA contravene Articles 14, 19, and 21 of the Azurian Constitution by bestowing arbitrary powers upon the government without adequate safeguards for individual rights. They argued that the Act was being leveraged to silence dissent, warning that its misuse set a dangerous precedent for curtailing freedom of speech. ACLJ also alleged that the Government uses this Act primarily to target followers of Solarism.
- 14. The Supreme Court has consolidated both petitions and decided to adjudicate the matter on these issues:
- I. Whether the Writ Petitions are amenable to the Writ Jurisdiction of the Honorable Supreme Court of Azuria?
- II. Whether the Unilateral Power of the Executive to designate an Individual as a Terrorist Under Section 35 and 36 of the UAPA violates the fundamental Principles of Criminal Jurisprudence, Rule of Law and Natural Justice?
- III. Whether the 2019 amendment to the Unlawful Activities (Prevention) Act, 1967, is manifestly arbitrary and violative of Articles 14, 19 and 21 of the Constitution?





RULES FOR MOOT COURT COMPETITION

1. ELIGIBILITY, TEAM COMPOSITION

- a) Students pursuing Three Years / Five Years LL.B. Course from any law School/College /University in India recognized by the Bar Council of India (BCI) are eligible to participate.
- b) Law Schools/Colleges/Universities are entitled to nominate not more than two teams.
- c) Teams shall comprise of 3 members (two designated as MOOTER and one as RESEARCHER).

2. LANGUAGE, DRESS CODE AND CONDUCT

- a) The official language of the competition shall be English.
- b) Female participants are required to wear either a full suit comprising of black formal blazer and trousers, full sleeved white shirts or white kurta, black bottom wear, black blazer/ over coat with formal foot wear.
- c) Male participants are required to wear a full suit comprising of black formal blazer and trousers, full sleeved white shirts, black tie and formal foot wear.

3. REGISTRATION

4. CLARIFICATION

5. MEMORIAL SUBMISSION

- a) Each Team must prepare memorials for both parties, i.e., the Petitioner and the Respondent. A soft copy of each side of the memorials must be e-mailed to the administrators (in PDF) at lawevent@lordsuniversal.edu.in latest by 13th February 2025 (18:00 hours IST) and the subject of the email should be "Submission of Memorials for Lex-Loci 2025.
- b) The file names of the electronic copies of the Memorials must contain only the team code and the side being represented (P for Petitioner & R for Respondent). E.g. Petitioner Memorial of Team Code-I should be named IP- Five hard copies of each side of the memorials (10 in total) must be submitted to the administrators latest by 15th February, 2025 (18.00 hours IST). The hard copies must be identical to the soft copy, else, disqualification would ensue.







c) Format of the Memorials

The Memorial shall be printed on only one side of A4 size paper, with the following mandatory formatting specifications:

- 1 inch margin on all sides:
- Times New Roman typeface with 12 font size; and
- 1.5-line spacing.
- · Citation style: Bluebook edition
- Teams shall cite authorities in the Memorial using footnotes.
- Explanatory or illustrative footnotes are not allowed. For footnotes, the formatting specifications are:
 - i. Times New Roman typeface with 10 font size; and
 - ii. Single (1) line spacing.
- · The Memorials shall be spiral bound.
- The following color scheme shall be followed for the Cover Page of the Memorials: PETITIONER: BLUE and RESPONDENT: RED (The cover pages are already color coded in the sample memorial).
- The Arguments advanced shall not be in more than 20 pages.

6. PENALTIES

- a) Late Submission: 2 points for every 12 hours delay; disqualification after 48 hours.
- b) Incorrect filename: 1 point per file.
- c) Improper formatting: I points for each instance.
- d) Improper citations: 2 points.
- e) Exceeding page limit in argument advanced: 2 points per page.

7. EXCHANGE AND RETURN OF MEMORIALS

- a) There shall be an exchange of Memorials between the respective opposing Teams in accordance with the rules and regulations of the institution prior to all the rounds of the competition.
- b) The Teams are prohibited from making any marks on the exchanged Memorials and must return the Memorials to the administrators after each round.
- c) The Draw of Lots & Exchange of Memorial shall be conducted on 14th February, 2025.







8. ORAL ROUNDS

Rules of Oral Submission

- a) The time split between the speakers must be communicated to the Court Masters prior to the commencement of each Round. Once informed, these timings may not be changed.
- b) Delay in appearance for a round exceeding five (5) minutes will lead to the disqualification of the team for that round. In such a case, their opponent shall make their oral submissions exparte.
- c) Any Compendium of cited authorities may be submitted to the Court Masters prior to the oral pleading session. However, any further document may also be submitted during the proceeding, at the discretion of the bench.
- d) Use of any electronic device is prohibited during oral rounds.
- e) Team members may pass written material to the Orator who may be speaking, in a discreet manner without disrupting Court proceedings.

PRELIMINARY ROUNDS

- a) Each team might not have to argue from both the sides.
- b) Time limit for the oral submissions in this round shall be fifteen (15) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than eight (8) minutes for his/her individual oral submissions.
- c) Only one speaker from each team shall be permitted to rebut/sur rebut and team shall not reserve more than three (3) minutes for rebuttal or sur rebuttal; and the sur rebuttal shall be limited to the point of rebuttal made by the opponent team & upon the discretion of the Judge.

QUARTER-FINAL ROUND

- a) Top eight teams will enter the quarter final round.
- b) Time limit for the oral submissions shall be fifteen (15) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than eight (8) minutes for his/her individual oral submissions.
- c) Only one speaker from each team shall be permitted to rebut/sur-rebut and team shall not reserve more than four (4) minutes for rebuttal or stir-rebuttal; and the sur-rebuttal shall be limited to the rebuttals made by the opponent team & upon the discretion of the Judge.





SEMI FINAL ROUND

- a) Time limit for the oral submissions shall be thirty-five (35) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than twenty (20) minutes for his/her individual oral submissions.
- b) Only one speaker from each team shall be permitted to rebut/sur-rebut and team shall not reserve more than four (4) minutes for rebuttal or stir-rebuttal; and the stir-rebuttal shall be limited to the rebuttals made by the opponent team & upon the discretion of the Judge.

FINAL ROUND

- a) Time limit for the oral submissions shall be forty-five (45) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than twenty-five (25) minutes for his/her individual oral submissions.
- b) Only one speaker from each team shall be permitted to rebut/sur-rebut and team shall not reserve more than seven (7) minutes for rebuttal or sur rebuttal; and the sur rebuttal shall be limited to the rebuttals made by the opponent team & upon the discretion of the Judge.

9. STRUCTURE OF THE ROUNDS

- a) Top eight (8) teams will qualify from Preliminary Rounds for the Quarter-final Round,
- b) Top (4) teams to qualify from Quarter-final Round to the Semi-final Round and
- c) Top (2) teams will qualify from Semi-final Round to the Final Round.
- d) The side on which a team will be arguing will be decided by draw of lots.
- e) In case of tie the memorial marks will be considered.

The Client Counseling Competition is a competition that aims to encourage the promotion and development of the skills involved with client interviewing/counseling within an educational context.

Communication along with ability to build trust helps to encourage a client to confide in you is one of the most important qualities in a lawyer and the benefits of taking part in this competition is immeasurable. It is an event which focuses on the invaluable skills of interviewing, counseling and centers on a simulated law office interview. The main essence of the competition is to promote a healthy lawyer-client relationship.

Rules And Regulations:

- 1. Each college can send 2 teams of 2 participants.
- 2. The duration of the competition is maximum 15 minutes.
- 3. The problem for the competition will be given on the spot.
- 4. The participants are required to provide most suitable legal solution to the given problem.
- 5. Judges shall observe and evaluate you on how well you are able to counsel your client and offer him a practical solution to his problem.

Rules And Regulations:

- I. Each College can send 3 participants individually.
- 2. Questions asked shall be based on Law Syllabus, Current Affairs and Legal General knowledge.
- 3. There will be three rounds:
 - a) 1st Round Fastest Finger First
 - b) 2nd Round Visual & Buzzer Round
 - c) Final Round Rapid Fire Round
 - d) Quiz shall be held in English only.
 - e) There will be no negative marking in Round 1 & Round 2.
 - f) However, the final round will carry negative marking of 0.50 marks for every wrong answer.







LEGAL DRAFTING

If you are a master in jugglery of words, then this is the contest for you!

Although mastering legal drafting skills takes time and practice, nevertheless, this competition would enhance your drafting skills. The participants must come prepared in topics like drafting a Suit, Writ Petition, PIL.'s, Written Statement, Conveyances such as Deed of Sale, Agreement of Sale, Lease Deed, Deed of leave & License etc.

Rules And Regulations:

- 1. The Acts relevant to legal drafting will be notified on 11th February, 2025 by 5.00 p.m.
- 2. The Draft must be submitted in English only.
- 3. Each college can send one team of maximum 2 participants.
- 4. The participants should bring their Own Bare Act's. NO books will be provided by the organizers.
- 5. Use of internet or books other than Bare Acts is strictly prohibited
- 6. The Petition/Application/Draft is to be prepared within 150 minutes (i.e. 2.30 hours)
- 7. Each entry shall be scrutinized by a panel of experts.
- 8. Special consideration will be placed on originality, applicability and feasibility of legal drafting, extent of research and most importantly the scope of the Draft.
- 9. All entries will be marked anonymously. Every team shall be allotted a team code after registering for the competition. The team members shall only use their code during the competition.
- 10. The participants are required to Draft as per the instructions provided to them.





APUD EXPLORATION

Legal research is an essential lawyering skill. The ability to conduct legal research is essential for lawyers, regardless of area or type of practice. The basic step is to find the leading case laws governing the issues in question. Therefore, case law studies are past legal decisions that help to investigate underlying principles of law applicable to the case in hand.

Apud (latin-'in the writings or or 'reference to') Exploration conjures and tests a student's ability in techniques of legal research and analysis that forms an integral part of lawyering skills.

Rules And Regulations:

- 1. Each college can send only 2 participants.
- 2. In Round I, a brief description of 15 cases will be provided to each participant. They will be given 20 minutes to search for 15 cases. Then, they shall have to answer in the given round with name of the parties and three citations. Eight participants will qualify for the final round.
- 3. In case of a Tie-Breaker, facts in brief of landmark judgments shall be provided and the Teams will have to identify the name of the cases. No usage of internet will be allowed for this round.
- 4. In the Final round, 6 situational problems and 50 landmark judgments will be given and participants have to find which case law is relevant to which problem within 60 minutes.
- 5. Use of mobile phone or any reference materials is strictly prohibited.
- 6. A Computer with internet facility and access to google will be provided.

TREASURE HUNT

Treasure Hunt challenge is a fun activity that includes general knowledge and legal questions, brainteasers and more. The event demands active and prompt use of skills and is sure to keep everyone busy.

Rules And Regulations:

- 1. Each college can send one team comprising of 3 members. Leaving the campus during the game is strictly prohibited.
- 2. Requirements for the events will be provided by the information desk i.e. pen and paper. No other requirements are needed for playing the game.
- 3. Each Team should announce a leader at the time of registration.
- 4. Each registered Team will get a unique identification number upon registration. Each Team leader should pin the identity card provided, while the Team is in action.





EXTEMPORE

Extempore is the art of public speaking that is carried out without preparation or forethought. It puts to test one's ability to think on the spot and also their spontaneity. Extempore is one such method which assists the students not only in thinking on their own but also in voicing their creative ideas with precision.

Rules And Regulations:

- 1. It is a solo event
- 2. Each college can send maximum 2 participants.
- 3. Each participant shall speak for 2 minutes on the topic handpicked by them.
- 4. A bell shall ring at the end of 2 minutes. Marks shall be deducted if they exceed time limit.
- 5. The medium of language shall be English only.


