Admission Procedure, Rules & Regulation (B.A. LL.B. 5 years/ LL.B. 3 years):

The admission for first year B.A. LL.B. (5years)/LL.B (3 years) will commence to the date notified by the DHE. Seats will be allotted to the institution by the competent authority conducting CET of Maharashtra State. Merit list of admissions will be displayed on the college notice board as per notification of DHE. Selected candidates will have to seek admission within specified date notified by DHE. The admission must be taken by the student only.

1. Eligibility for admission to B.A. LL.B. 5 years Integrated Course - The candidate should be an Indian citizen.

1.1 Educational qualification: An Applicant/Candidate who has successfully completed Senior Secondary School Course ('+2') or equivalent, such as (11+1, 'A' level in Senior School Leaving Certificate Course) from a recognized University of India or Outside or from Senior Secondary Board or Equivalent, Constituted or recognized by the Union or by a state Government or from any Equivalent Institution from a Foreign Country recognized by the Government of that Country for the purpose of issue of Qualifying Certificate on successful completion of the Course/Examination, with minimum of 45% Marks in Aggregate*(no rounding of allowed) and 40% Marks in Aggregate in degree examination in all parts of the Degree

Examination for candidates belonging to SC and ST Category belonging to State of Maharashtra only and minimum 42% marks in Aggregate in degree examination in all parts of the Degree Examination for candidates belonging to VJNT, SBC and OBC category belonging to State of Maharashtra only [*no rounding of allowed]. Ref: (Government of Maharashtra Gazette, Extraordinary, Part-IV-B, No. 102, Dated 24th April 2017.)

The Candidates belongings to the type [Non Resident Indian, Person of Indian Origin, Overseas Citizen of India and Foreign National Students, Children of Indian Workers in the Gulf Countries] with Academic

Eligibility mentioned above are not required to appear for CET- 2023 Examination. They must directly apply only for Centralized Admission Process (CAP).

1.2 Explanation:

- I. An applicant who has successfully completed Senior Secondary School course ('+2') or equivalent such as (11+1, 'A' level in Senior School Leaving Certificate Course) from a recognized University of India or outside or from Senior Secondary Board or equivalent, constituted or recognized by the Union or by a State Government of India or from any equivalent institution from a foreign

country recognized by the Government of that country for the purpose of issue of qualifying certificate on successful completion of the course may apply for and be admitted in to the Programmed of the Centres of Legal Education to obtain the integrated degree in Law with a degree in any other subject as the first degree from the University whose such degree in law is recognized by the Bar Council of India for the purpose of enrolment. Ref.: (BCI: Legal Education Rules 2008)

II. Provided that applicant who have obtained +2 Higher Secondary pass certificate or the first-Degree Certificate after prosecuting studies in Distance or Correspondence methods shall also be considered as Eligible for admission in the Course. There should be a gap of not less than Two Years between 10th Std. (SSC) and 12th Std. (HSC) (i.e., a Candidate who has qualified SSC Examination in March 2013 should have qualified HSC Examination Not Before March 2015.) Bar Council of India Legal Education Rules-2008 and Circular No: LE: Cir.:02/2010 dated 20th December 2010.

III. Provided further that the applicants who have obtained 10 Std./Secondary Schooling Certificate Examination, in a Single Sitting Examination without

having any Basic Qualification (1st To 9th Standard of Schooling) is not Eligible For admission to the 5 Yrs. LL.B. Course. References: Bar Council of India Legal Education Rules-2008 and BCI Circular No: - LE: Cir.:02/2010 dated 20th December 2010 & BCI Affidavit in WP-11378/2016. IV. The candidates who have completed 10(SSC)+2 (HSC) education following regular mode (10th, 11th, 12th) are only eligible for admission.

1.2. Eligibility for Admission to LL.B. 3 Years Degree Course .

2.1 The candidate should be an Indian National.

Educational Qualifications:

2.2 (a) The candidate should be a Graduate and or Post Graduate in any Faculty/ Discipline of Knowledge of any University in Maharashtra established by an act of Parliament or by the State Legislature or an equivalent National Institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an Authority competent to declare equivalence, with Minimum 45% Marks in Aggregate* for Open Category Candidates i.e. 45% Marks

in Aggregate* (for all the parts of the Degree Examination taken together), 40% Marks in Aggregate in degree examination in all parts of the Degree Examination for candidates belonging to SC and ST Category belonging to State of Maharashtra only and minimum 42% marks in Aggregate in degree examination in all parts of the Degree Examination for candidates belonging to VJNT, SBC and OBC category belonging to State of Maharashtra only [*'no rounding of allowed']. Ref: (Government of Maharashtra Gazette, Extraordinary, Part-IV-B, No. 102, Dated 24th April 2017.)

2.2 (b) The Candidate who has passed the 3-year Undergraduate Degree and or 2/3 Yrs. Post Graduate Degree from university mentioned above in 2.2 (a) after prosecuting the studies in the educational pattern of 10+2+3 and/or 10+2+3+2/3 Yrs. with Regular Studies at Secondary (SSC) and Higher Secondary (HSC) Schooling.

2.2 (c) Provided that, the Candidate who has obtained +2 (Higher Secondary) Certificate or First-Degree Certificate and or Post Graduation Certificate by Distance or Correspondence Method shall also be considered as Eligible for CET of LL.B. - 3 Yrs. Full Time Regular Course.

2.2 (d) Explanation: The Candidate who has passed the qualifying examination (10+2, UG and or PG) in a single sitting examination without having Basic Qualification of (10+2+3 and or +2/3) is not eligible. Further provided that, No Candidate from Open University having a Degree contrary of the UGC Act and Regulations and contrary to Rules of Legal Education shall be eligible. (Ref:1) Government Notification in Extra ordinary Gazette dated 24th April 2017.2) Government Notification in Extra ordinary Gazette dated 5th May 2017, 3) Bar Council of India-2008: Part V-5(a)).

2.2 (e) The candidates who have completed 10(SSC)+2 (HSC) education following regular mode (10th, 11th, 12th) are only eligible for admission.

Centralized Admission Process (CAP):

(1) The Unaided Private Professional Educational Institution shall admit Candidates through the Centralized Admission Process (CAP) as referred to in sub-section (3) of section 3 of the Act. The stages of Centralized Admission Process (CAP) shall be as stated below,-

(a) Display or publishing of Information Brochure by the Competent Authority in consultation with the concerned Directorate;

- (b) Filling online application form by Candidate for participation in the Centralized Admission Process (CAP);
 - (c) Uploading of scanned images of valid necessary original documents as per the requirement of the admissions while filling of online application form;
 - (d) Document Verification at Admission Reporting Centre by the Candidate. It is mandatory on the Candidate's part to produce all original document in support of the claim made in the application form;
 - (e) Display or publishing of provisional merit lists, submission of grievances, if any, and display or publishing of final merit lists;
 - (f) Display of available Category wise Seats (Seat Matrix) available for respective CAP Rounds;
 - (g) Filling up and confirmation of online option form having preferences of Institutions prior to CAP Round-I and CAP Round-III. Candidates may fill in performances of Institutes in decreasing order of their preference as specified by the Competent Authority. The option form once confirmed prior to CAP Round-I shall be considered for allotment in the CAP Round-I and II and the option for confirmed prior to CAP Round III shall be considered for allotment in CAP Round III only;
 - (h) Display of provisional allotment of respective CAP Rounds indicating allotted institute;
 - (i) Candidate shall accept the offered seat by paying seat acceptance fee at Admission Reporting Centre (ARC) from Candidate's login as per the schedule declared by the Competent Authority;
 - (j) Only after seat acceptance as per clause (i), the Candidate should report to the allotted institute for seeking admission on the allotted seat as per final allotment in CAP rounds.
 - (k) The time schedule prescribed by Competent Authority for compliances for various stages of CAP is mandatory.
- (2) **Conduct of CAP Round –I.-** The seats available for Round-I shall be published on the website. The Candidate whose names appeared in the final merit list of CAP shall be eligible to participate in this round by filling online option form. The

Candidate shall fill and confirm the option form through Candidate's Login.

(3) During the CAP

- (a) If a Candidate is allotted the seat as per his first preference, such allotment shall be auto freezed and the Candidate shall accept the allotment so made. Such Candidate shall then be not eligible for participation in the subsequent CAP rounds. Such Candidates shall then report to ARC for verification of documents and payment of seat acceptance fee through Candidate's Login. Thereafter such Candidate shall report to the allotted institute and seek admission on the allotted seat. If such Candidate does not report to ARC for confirmation of seat acceptance, their claim on the allotted seat shall stand forfeited automatically and the seat shall become available for fresh allotment. For such Candidate, the allotment so made shall be the final allotment. (b) Candidate who have been allotted seat other than the first preference given by the Candidate and if the Candidate is satisfied with such allotment and do not wish to participate in further CAP rounds, such Candidate can freeze the offered seat through Candidate's Login. Once the Candidate freezes the allotted seat,

such Candidate shall then report to ARC for verification of documents and payment of seat acceptance fee. Thereafter such Candidate shall report to the allotted institute and seek admission on the allotted seat. For such Candidate, the allotment so made shall be the final allotment. If such Candidate does not report to ARC for confirmation of seat acceptance, their claim on the allotted seat shall stand forfeited automatically and the seat shall become available for fresh allotment. The Candidate who freezes the seat shall then be not eligible for participation in the subsequent CAP rounds.

- (c) Candidate who have been allotted seat other than first preference and accepted the seat by reporting to the ARC for confirmation of seat by paying the seat acceptance fee through Candidate's Login shall be eligible for participation in the subsequent rounds for betterment.
- (d) Candidate who have been allotted seat other than first preference and not accepted the seat by not reporting to ARC for confirmation of seat acceptance and not paying the seat acceptance fee through Candidate's

Login shall be eligible for participation in the subsequent rounds.

(4) Conduct of CAP Round II.

- (a) The seats available for Round II shall be published on the website.
- (b) Round II will be betterment Round for those Candidates who have been allotted seat other than first preference and who have been not allotted any seat in Round-I.
- (c) There shall be no further betterment option available to the Candidate after Round II. The allotment made and/or allotment retained in Round II shall be final.

(5) Conduct of CAP Round III.

- (a) The seats available for Round III shall be published on the website.
- (b) The Candidates eligible for Round III are allowed to fill in and/or edit online option form filled in by the Candidate for the previous round. The CET qualified Candidates who have failed to register themselves before CAP Round I for the Centralized Admission Process (CAP) shall be eligible to register for Centralized Admission Process (CAP) before Round III. But the Merit List of such

newly registered Candidates will be published separately and they will be placed below the Candidates whose names have been published in the first Merit List.

The seats to be allotted during these rounds shall be available to the eligible Candidates falling under the following categories:—

- (i) Candidates as per the sub-rule 3 (c) and 3 (d) above.
- (ii) Candidate who have not been allotted any seat in any of previous rounds.
- (iii) CET Qualified newly Candidates who did not participate (failure of filling CAP application form and option form) in previous round.
- (c) Candidates who have been allotted seat other than first preference and reported to Institution for confirmation of seat acceptance, whilst filling fresh option form, he need not fill the preference already allotted to the Candidate in the previous round. Once upward preference is allotted to such Candidate, his earlier seat allotment shall stand automatically cancelled due to application of dynamic allocation. If the Candidate is not

allotted seat in Round III, the seat allotted in Round I or II, as the case may be, shall be retained automatically but the Candidate will have to report to ARC and Concerned College or Institute for Confirmation of Admission.

- (d) At the time of reporting to the allotted college or Institution for confirming the allotted seat, the Candidate shall submit all the original documents in support of the claims made in the application. In that event, if the Candidate fails to produce the documents in support of the claims, so made in the application, the allotment shall stand cancelled automatically and the seat shall become available for allotment in further rounds.
- (e) The Candidate will be entitled to rectify the following errors in the application form at the time of scrutiny of documents at ARC viz. (i) change of gender from male to female and vice-versa; (ii) error while entering marks obtained by Candidate in examination, CET. However, the change in the merit number declared vide First Merit List due to increase in the marks will not be permitted. (iii) error with mentioning the caste, sub-caste, the category of backward class. A reserved category Candidate will be

allowed to change his category from Reserved to General upon his failure to submit requisite documents like Caste Certificate, Tribal Certificate, Validity Certificate, Non-Creamy Layer Certificate, etc. as the case may be. (iv) removal of minority status due to failure of submission of supporting documents; (v) removal of Disability status due to failure of submission of supporting documents; (vi) removal of Defense status due to failure of submission of supporting documents; (vii) Change in type of Candidature; (viii) change in Qualification. Apart from the above, no other change or rectification shall be allowed.

- (f) In case of additional round (if any), the category of Candidates mentioned in clause (b) above shall be entitled to participate and will be entitled to fill in fresh option Form. In such case, the Candidate need not fill in the previously allotted preference in their preference list. Once the upward allotment is made, the earlier allotment shall stand automatically cancelled. If the Candidate is not allotted seat in additional round (if any), the seat allotted in previous Round as the case may be, shall be retained automatically but the Candidate will have to report to ARC

and concerned College or Institute for Confirmation of Admission.

- (6) The Candidate shall report to the institution finally allotted to him and confirm his admission in College or Institution as per the schedule. The College or Institute shall verify the required documents and upload the admission of the Candidates in the online system through Institute Login immediately and shall issue a system generated receipt of confirmation of admission to the Candidate."

The Colleges/Institutions shall accordingly issue the grade cards to them after conversion of marks into the grades as per the procedure mentioned in this manual. The format of the grade card is given herein below to maintain the uniformity across the all colleges for the examinations conducted by the colleges on behalf of the University.

For the Semesters I to IV of the 3 Years LL.B. programme and Semesters V to VIII of the 5 Years B.A. LL.B. programmes, the assessment of 'Part A' i.e. Internal Assessment and Part B i.e. Semester End Examination shall be processed by the Colleges/Institutions of their learners on behalf of the University and declare their results as per the procedure laid down by the University. The Colleges/Institutions shall accordingly issue the grade cards to them after conversion of marks into grade as per the procedure mentioned in this manual. The format of the grade is given herein below to maintain the uniformity across all colleges for the examinations conducted by the colleges on behalf of the University.

For the Semesters V- & VI of the 3-Years LL.B. programme and Semesters IX and X of the 5 Years B.A. LL.B. programme, the assessment of 'Part A' i.e. Internal Assessment

shall be processed by the Colleges/Institutions on behalf of the University of the learners admitted for the programme while the University shall conduct the assessment of 'Part B' i.e. Semester End Examination. The Internal Assessment marks of learners appearing for these Semesters shall be submitted to the University by the respective colleges/Institutions before commencement of respective Semester End Examinations. The Semester End Examinations for Semesters V & VI of the 3 Years LL.B. programme and Semesters IX and X of the 5 Years B.A. LL.B. programme shall be conducted by the University and the results shall be declared after processing the internal assessment and the marks awarded to the learners. The grade cards shall be issued by the University after converting the marks into grades.

c) Conducting Applied Component Courses' Examinations:

The Examinations for the Applied Component Group Courses/Papers of the 3 years LL.B. programme and of the 5 years B.A. LL.B. programme respectively shall be conducted by the respective college/institution of their learners on behalf of the University and finalize their results as per the rules and regulations laid down by the University from time to time. The marks of the Applied Component Courses of learners appearing shall be submitted to the University by the respective colleges/Institutions before commencement of the next ensuing Semester End Examinations.

TEN POINT GRADING SYSTEM

University of Mumbai vide its circular bearing No. UG/79 of 2016-17 dated 14th October 2016 laid down that the 10 point Grading System, prepared by the Special Committee constituted for the purpose at its meeting held on 1st September 2016, has been accepted by the Academic Council at its meeting held on 30th September 2016, and that in accordance therewith, the following scheme for the uniform 10 point grading system has been implemented. The Grading System adopted by the University of Mumbai is as follows:

Note: Consider 1 Grade Point is equal to Zero for CG calculations of failed learner/s in the concerned course/s. University of Mumbai vide its circular bearing No. UG/46 of 2019-20 dated 20th May 2019 implemented the CBCS for Semester I of Three Years and Five Years LL.B. Programme from the Academic Year 2019-20 and made it applicable progressively for the students taking admission for both the Law Programmes.

GENERAL GUIDELINES FOR ASSIGNING COURSE WISE CREDIT

The Credits are defined in terms of the learner's hours which are divided into two parts, such as Actual and Notional. The value of a particular course can be measured in number of Credit Points. The value of One (01) Credit is equal to 30 Hours. The Scheme of Examination shall be divided into two parts, i.e. Internal Assessment includes Assignments, Seminars, Case Studies and Unit Tests which will be of 40 marks and the Semester End Examinations which will be of 60 marks. The semester wise Credit Points will be varied from programme to programme, but the value of Credits for Under Graduate Programmes shall be of 120 Credits in the Faculty of Law.

ASSIGNMENT OF CREDITS

One (01) credit is approximately equal to thirty (30) hours of the learner's load for all UG (Undergraduate) programmes and these credits is divided in to two parts:

- one half of the hours actually spent in classroom/practical/field work instructions
- other half of the hours notional spent for self-study in library, institutions or at home, case study, writing of journal and assignments, projects, visiting Government Offices/Police Stations/Jails/Juvenile Homes/Offices of the Non-Governmental

Organization/Courts/ Registrar's Office and all other places, offices, etc. for the purposes of collecting the data or understanding of the working of the respective system by the learners him/herself for the completion of that course.

The UG programmes carry following value credits for 3 years LL.B. programme and 5 years integrated B.A. LL.B. programme in the Law Stream in the Faculty of Humanities:

UNFAIR MEANS

Use of Unfair Means by the students during the Examination

**PROCEDURE FOR INVESTIGATION
IN CASE OF MALPRACTICES**

1. A student who is caught talking in the classroom during the examination, possession of any electronic equipment/s/ mobile / smart watch or is found resorting to any of the acts listed below will be treated as case of use of unfair means.
2. The Junior Supervisor / Block Supervisor (JS / BS) shall prepare a report about the use of unfair means resorted by the student and the student will also prepare and submit his / her statement in the format prescribed. The JS / BS shall take away the original answer book of the student and shall issue the new answer book to the student.
3. The Senior Supervisor shall be informed of the above matter and at the end of the examination, the BS / JS shall collect the original answer book and the new answer book, issued to the student and submit the same separately to the Senior Supervisor. The Senior Supervisor shall forward the answer books, his report along with the report of the JS and Statement of the Student along with the copy of the question paper in a separate sealed envelope to the Chief Conductor who shall

hand over the envelope to the Chairperson of the Unfair Means Inquiry Committee with due acknowledgment.

4. The candidate may be served a show cause notice and made aware of the charges/ allegations reported against him to prepare his/her defence at the time of his/her appearance before the Unfair Means Inquiry Committee and informing him/her thereby, of the proposed action to be taken in his/her case with a request to reply to the show cause notice as to why the action proposed under it should not be taken against him/her.
5. The student may submit his/her defence in writing to the committee before or during the meeting. The reply received by the Committee from the candidate when he/she appears before it and the oral submissions / clarifications given by the

student, will be considered by the Committee and the committee shall submit its final recommendation to the Principal based on the evidence before the committee.

6. The punishment finally awarded can be equal to or less than what is mentioned in the show cause notice, but not more than what is mentioned therein.
7. The College Unfair Means Inquiry Committee is a recommendatory body. The Principal has to exercise his / her power U / S 87 of the Mumbai University Act, 1974 and issue final order.

The Broad Categories of Unfair Means Resorted to by Students at the University / College / Institution Examinations and the Quantum of Punishment for each category thereof.

Unfair means	Quantum of Punishment
(1) Possession of copying material	Annulment of the performance of the student at the University/ College/ Institution examination in full. Note: - This quantum of punishment shall apply also to the following categories of malpractices at Sr. No. (2) to Sr. No. (12) in addition to the punishment prescribed thereat.
(2) Actual copying from the copying material	Exclusion of the student from University or College or Institution examination for one additional examination
(3) Possession of another student's answer book	Exclusion of the student from University or College or Institution examination for one additional examination. (BOTH THE STUDENTS)

Unfair means	Quantum of Punishment
(4) Possession of another student's answer book + Actual evidence of copying there from.	Exclusion of the student from University or College or Institution examination for two additional examinations. (BOTH THE STUDENTS)
(5) Mutual / Mass copying	Exclusion of the student from University or College or Institution examination for two additional examinations.
(6) i. Smuggling-out or smuggling-in of answer book as copying material. ii. Smuggling-in of written answer-book based on the question paper set at the examination. iii. Smuggling-in of written answer book and forging signature of the Jr. Supervisor thereon.	i. Exclusion of the student from University or College or Institution examination for two additional examinations. ii. Exclusion of the student from University or College or Institution examination for two additional examinations. iii. Exclusion of the student from University or College or Institution examination for two additional examinations
(7) Attempt to forge the signature of the Jr. Supervisor on the answer book or supplement.	Exclusion of the student from University or College or Institution examination for two additional examinations.
(8) Interfering with or counterfeiting of University / College / Institution seal, or answer books or office stationery used in the examinations.	Exclusion of the student from University or College or Institution examination for two additional examinations.
(9) Answer book, main or supplement written outside the examination hall or any other insertion in answer book.	Exclusion of the student from University or College or Institution examination for two additional examinations.
(10) Insertion of currency notes/to bribe or attempting to bribe any of the person/s connected with the conduct of examinations.	Exclusion of the student from University or College or Institution examination for two additional examinations.
(11) Using obscene language / violence threat at the examination center by a student at the University / College / Institution examination to Jr. / Sr. Supervisors / Chief Conductor or Examiners.	Exclusion of the student from University or College or Institution examination for two additional examinations.
(12) (a) Impersonation at the University/ College/ Institution examination. (b) Impersonation at the University / College / Institute student at S.S.C./ H.S.C. any other examinations.	Exclusion of the student from University or College or Institution examination for two additional examinations. Exclusion of the impersonator from University or College or Institution examination for five additional examinations.

Unfair means	Quantum of Punishment
(13) Revealing Identity in any form in the answer book by the student at the University or College or Institution examination.	Annulment of the performance of the Student at the University or College or Institution examination in full.
(14) Found having written on palms or on the body, or on the clothes while in the examination.	Annulment of the performance of the student at the University or College or Institution examination in full.
(15) All other malpractices not covered in the aforesaid categories.	Annulment of the performance of the student at the University or College or Institution examination in full, and severe punishment depending upon the gravity of the offence.
(16) If on previous occasion a disciplinary action was taken against a student for malpractice used at examination and he/she is caught again for malpractices used at the examinations, in this event he/she shall be dealt with severely. Enhanced punishment can be imposed on such students. This enhanced punishment may extend to double the punishment provided for the offence, when committed at the second or subsequent examination.	
(17) Practical /Dissertation/Project Report Examination. Student involved in malpractices at Practical / Dissertation/ Project report examinations shall be dealt with as per the punishment provided for the theory examination.	

The Competent Authority, in addition to the above-mentioned punishments may impose a fine on the student declared guilty.

(Note: The term “Annulment of Performance in full” includes performance of the student at the theory as well as Annual Practical examination, but does not include performance at term work, project work with its term work, oral or practical and dissertation examinations unless malpractice used threat.)

Code of Conduct and College Regulations

Attendance: Compulsory 75% attendance to appear for all exams.

General Rules of Code of Conduct:

1. Students joining the college have to strictly bind by the Rules and Regulations of the college.
2. The student should remain personally present at the time of Admission.
3. All the students who have taken admission in the College must possess valid Identity Card. (Identity Cards are issued by the college at the time of admissions). Students must carry with them their Identity Card and should produce it when demanded by the Teaching & Non-Teaching staff. Identity Card should be carefully preserved. The holder of the Identity Card will be held responsible for its misuse. In case of loss of Identity Card, a duplicate must be obtained by paying the prescribed charges.
4. It is the responsibility of the student to read the notice boards regularly for important announcements made by the College authorities from time to time. They will not be excused or be given any concession on grounds of ignorance.
5. Students should submit applications for scholarship/freeship and other documents along with the Enrolment
6. Students must maintain silence in Library, Reading Room, Office and the corridors. When they are free, they should make use of the College Library, and must not loiter in/ around the college premises or assemble in the corridor. Loud conversation and shouting should be avoided.
7. Students are expected to follow decent dress code as notified by the university. The college authority reserves the right to refuse entry to student in the college premises for indecent dress code.
8. As per University Ordinance 6086 Minimum 75% attendance and satisfactory progress in studies are the essential requirements for students to become eligible for being sent up for College/University Examinations.
9. In case of illness, a student must apply for leave, as soon as possible, with a doctor's certificate. He/She must personally report to the college office in-charge on resuming class.
10. Admission to a class does not automatically guarantee admission to higher classes in future. Admission to all classes will be based on performance and availability of seats.

11. Smoking and consumption of alcohol is strictly prohibited on the campus.
12. Use of mobile is strictly prohibited in classrooms. Students are not permitted to use any video or photo camera, including cameras within mobile phones, in the campus.
13. Students are expected to take proper care of college property and to help in keeping the premises neat and clean. Causing damage to the property of the College, e.g. disfiguring walls, doors, fittings, or breaking furniture, etc., is a breach of discipline. Any such violation will invite strict disciplinary action.
14. Students must not associate themselves with any activity not authorized by the College Principal. Disciplinary action will be taken of students found organizing or participating in such unauthorized activities.
15. No student shall collect any money or contribution for picnic, trip and educational visit, get-together, study-notes, charity or any other activity without prior sanction of the Principal.
16. Students applying for certificates, testimonials, etc. and those requiring the Principal's signature on any kind of documents or applications should the College office. Students should bring no paper directly to the Principal for his/her signature.
17. No Society or Association can be formed in the College and no person/invitee can address a meeting without the Principal's prior permission and sanction.
18. Students should not leave their books, valuables and other belongings in the classroom or any other place in the college. The College is not responsible for their loss.
19. Students are prohibited from using the name of the college for the promotion of any private or individual event. Any such violation will invite strict disciplinary action.
20. No student shall use unfair means or indulge in disorderly conduct at or in connection with examination.
21. Students shall do nothing either inside or outside the College that will in any way interfere with its orderly conduct and discipline.
22. Insubordination, foul language or misconduct on the part of a student is sufficient reasons for his/her suspension or dismissal from the college.

23. No student shall communicate any information or write about the internal matters of the College in any manner to the Press or Media.
24. If, for any reason, the continuance of a student in the College is in the opinion of the Principal, detrimental to the best interest of the College, the Principal may ask such a student to leave the College without assigning any reason for his/her expulsion.
25. Matters not covered under the existing rules will rest at the absolute discretion of the Principal.
26. Students must surrender their Identity Card before taking admissions for next academic year.

Anti-Ragging

As per the circular from Joint Director, Higher Education, Maharashtra Government vide (Ref. 2005/238/05), vishi-1, dated 28th July 2007, the student found guilty of Ragging already will not be given admission in the college or if found guilty of Ragging even after admission in college will be removed /debarred from the college.

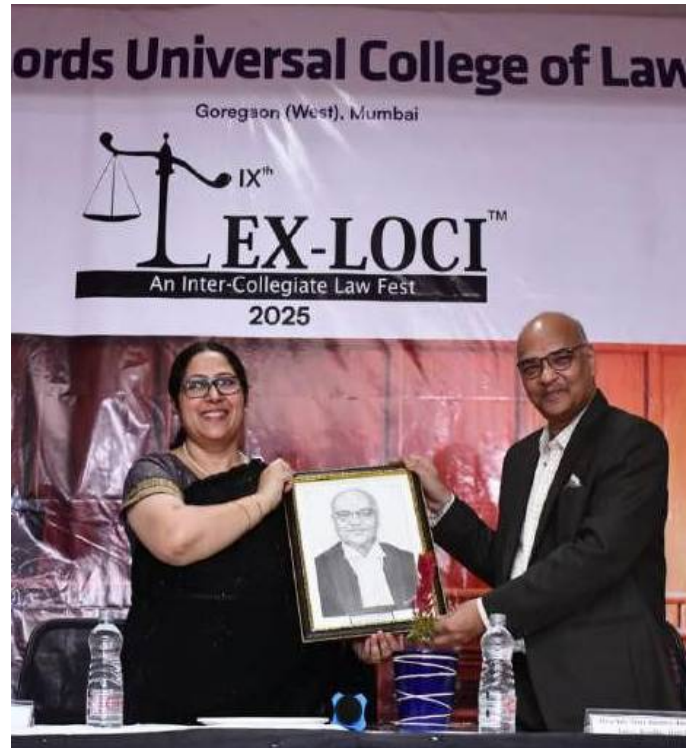
